

Enrolment Form 2022:

1- Flock Identification

- ☐ Fill your flock identification information in the blank space.
- ☐ If you don't already have your flock letters, please call the CLRC at 1-877-833-7110 to get them. The cost is around \$25 (for purebred) and \$15 (for commercial flock) and there is no annual fee if you don't register an animal. The flock letters are used to produce the unique identification for animals in the GenOvis program. You aren't obliged to tattoo your animals to participate in the program. CEPOQ may also assign you commercial flock letters upon demand.
- ☐ For sellers of breeding sheep, please update the breed or crossbreed that you sell. This information will be indicated on the list of participants on the GenOvis website. Many producers, who want to buy evaluated sheep, consult this list.

Services included in the annual membership (\$270)

- ☐ Flock initialisation (for the first 100 ewes)
- ☐ Flock inventory update
- ☐ GenOvis program participation certificate
- ☐ Lamb reports
- ☐ Animal performance certificate (on request only)
- ☐ Annual summary of each breed's provincial performances
- ☐ Flock evaluation report
- ☐ Consultation by phone or by e-mail
- ☐ Online access to the program and to your reports
- ☐ Breeding module online to calculate the consanguinity and genetic prediction of the offspring

Additional fee for

- ☐ Manual entry service for new lambs (\$2.89 per lamb)
- ☐ Manual entry service for lambs born in previous lambing (\$2.89 per lamb)
- ☐ Manual entry service to complete flock initialisation for additional reproductive animals (\$20.00 for every 100 additional animals)

**** There is no extra charge for animals (reproductive animals and lambs) that you enter by yourself. Furthermore, any assistance given to help you with your using the online program is included in the annual fees. *****

2- Preferences regarding the production of reports

A- Select a report language

B- Report preferences:

- ☐ Select one mode for sending your report. If you select more than one, then CEPOQ will retain either E-mail or Online program mode.
- ☐ Selecting **E-mail** means you will receive all your GenOvis reports by e-mail. If you enter data by your own, please e-mail us to receive your report by e-mail.
- ☐ Selecting **Online program** means you will access your customized reports on the GenOvis online program. If you use the data entry service, an e-mail will confirm that your data has been entered and will indicate when your reports will be available.
- ☐ Selecting **mail**: annual fee of \$36 applies
- ☐ By selecting E-mail or Online program, you are sure to receive your reports as soon as possible. Mailing reports through the postal service means a one-week delay.
